TERMS AND CONDITIONS (Trade)

DEFINITION OF SITE(S)

A Trade Stand Site is uncovered ground for a tent, mobile unit or other trade exhibit *ONLY*. All sites are a maximum depth of 10 metres. Stands encroaching over this depth will be liable to double frontage fees.

1. SPACE

Exhibitors must apply and pay for sufficient space to take trailer or caravan overhang, all stays or guy ropes for any building, tent or marquee. NB *Space reserved must include the total length/width of vehicle inclusive of all tow bars and guy ropes*. Boundaries of all spaces will be clearly defined and bear the block and stand number. In no circumstances will exhibits or guy ropes be allowed to encroach on land outside the Exhibitor's site. *Please ensure you reserve sufficient space to prevent encroaching onto gangways and any neighbouring sites. NB: Only one sleeping unit per site. Others park behind Marquee A or use Newby Caravan Park. MOTOR VEHICLES MUST NOT INTERFERE WITH, NOR CAUSE INCONVENIENCE TO OTHER EXHIBITORS / SPECTATORS BY THEIR PRESENCE.* See also Condition 5.

2. SUB-LETTING

No exhibitor will be allowed to sub-let any portion of the space allotted to him.

3. ARRIVAL / REMOVAL OF EXHIBITS

All trade traffic must be on the show field by 7.30 am on Friday, 16th, the first morning of the show and remain there until AFTER THE COMPLETION OF ALL JUDGING on each day of the show. No admission to the show field from: 8 p.m. Thursday, to 6.30 a.m. on Friday morning

Trade vehicles should use the road behind the line of Trade Stands to gain access to the Trade site.

Exhibits and stand equipment must be removed after the show has closed and in no circumstances later than noon on the day following the last day of the show.

THE EXHIBITOR WILL BE RESPONSIBLE FOR MOVING ALL WASTE MATERIAL OF WHATEVER NATURE FROM THE ALLOCATED SITE TO THE WASTE SKIPS WHICH ARE PROVIDED BY THE SOCIETY.

4. RESPONSIBILITY

All Trade Stand Holders must have and maintain, for the duration of their stay on the show field, their own PUBLIC LIABILITY INSURANCE for at least £2,000,000 against damage or injury to third party person or property. A copy of the current certificate of PUBLIC LIABILITY INSURANCE must be clearly displayed on the unit. The Society will not, in any way be responsible for mishap to any stand, equipment or article exhibited or displayed. It shall be a condition of entry for all Trade Stand subscribers that in every case, the Darlington Dog Show Society shall be indemnified against any legal proceedings that may arise from the loss, damage by fire, tempest or any other cause or mis-delivery of any article in any circumstances either before, during or after the completion of the show. The Society will not in any way be responsible for sales of coat preparations or shampoos or similar which are in contravention of Kennel Club Regulations for Preparation of Dogs for Exhibition F.

5. MOTOR VEHICLES

It shall be a condition of lease that *ALL* motor vehicles permitted on to the show field and not forming part of the Trade Stand display *MUST BE MOVED NOT LATER THAN 7.30 a.m. ON SHOW DAYS TO THE SPECIAL CAR PARK PROVIDED* within the precincts of the show. **ADDITIONAL CARAVANS** may be parked in the Newby Hall Caravan Park adjacent to the Car Park. Contact should be made in writing stating dates required to the Opening Administrator: Newby Hall, Ripon, North Yorkshire HG4 5AE.

Tel: 01423 322583. The management reserves the right to remove any vehicles incorrectly parked, by mechanical means, and recover such expenditure so incurred from the vehicle owner / driver.

6. RIGHT TO REFUSE The Show Management reserves the right, at its uncontrolled discretion :-

- a) to refuse to accept any Trade Stand application without explanation;
- b) to refuse admission of any person to the precincts of the show;
- c) to evict therefrom any person who does not comply with the conditions laid down by the Management of the show or causes any disorder.

7. FIRE SAFETY

All Trade exhibitors must provide an appropriate Fire Extinguisher..

8. SECURITY

Exhibitors are strongly advised to make overnight security arrangements to safeguard their property.
